A rules resource and regatta management tool for competitors, judges and race officials.

Background

- Started in 2014
- Currently has about 5000 race officials registered from around the world
- Generates about 100,000 page views a month
- Translated into eight languages, a few more in development
- GDPR and COPPA compliant. Meets the security requirements around the world.



Components

There are currently three components

- Rules
- Forums
- Toolbox



Components - Rules

- Rules Section
 - Rules, definitions, cases/calls integrated into one place.
 - Full versions of Match, Team and Kiteboard rules (not just appendices)
 - Prescriptions and appeals are included for several MNAs
 - Each user is able to add unique notes (visible only to them).
 - Links to the rules from the previous quad (2013 & 2017) integrated into the current rules for comparison.
- The Rules Section is maintained by the community through volunteer efforts of race officials.



Components - Forums

- Various forums for different subjects
 - General rules forum for most discussion and competitor questions
 - Rule 18 forum for the most discussed rule
 - Rule 2 and 69 forum for the most contentious
 - NOR/SI content sharing forum
 - Regatta management forum for issues around using RRS.org
- The forums serve as a repository of information concerning rules issues and many judges use it to solve rules issues during protests
- The forums also identify problems in the current rules



Components - Toolbox

- The toolbox is a set of tools to assist officials with the shore-side issues of a regatta.
 - Notice Board
 - Protest Hearings
 - Scoring Inquiries
 - Equipment and Crew Substitutions
 - Questions for the Jury
 - Penalty Reports
 - On-the-Water Penalties
 - Starting Penalties
- The goal of the application is to provide a communication channel between officials and competitors
 - Posting on a physical board is not always functional and the competitors expect more
 - Posting on the web is necessary, but not very useful
 - The toolbox communicates with competitors with email, text message, WhatsApp and mobile devices



Components – Toolbox Cont'd

- The toolbox communicates by email, text messages, WhatsApp and/or mobile:
 - The competitors are sent a message when the protest time limit is posted or an official posts an announcement.
 - The PRO is sent an email/text when a competitor submits a Scoring Inquiry. The PRO can actually review the requests and respond while still on the water.
 - The measurer is sent a text/email when an equipment substitution is submitted and can respond electronically.
 - The protestor, protestee and judges are sent an email/text when a protest is filed, a hearing scheduled or a decision filed.
 - The scorer is sent an email/text when a scoring change has been generated. The toolbox provides a panel for all the scoring changes no matter how they are generated - they all appear in one place.



Security

- RRS.org is hosted on a secure service (https)
- Data is secure and only available to officials at the relevant event
- RRS.org meets all the requirements of COPPA and GDPR.
- Competitor data is not used for anything other than for purposes of the event. It is not sold or used for advertising.
- The toolbox section is excluded from Google search, so nothing in the toolbox will appear in their results.
- Users are required to use real names and contact information, and the contact information is confirmed.
